Thank you very much for supporting the mission of the Catholic Diocese of Gary with a gift of appreciated stock. To complete your donation, please follow the steps outlined below. If further assistance is required, please contact Kathy Tomasik at the Diocese of Gary Pastoral Center, Finance department.

1. Complete and Submit the Stock Donation Letter of Intention (see page 2)

A properly completed **Stock Donation of Intention** (page 2) allows for proper processing of the stock transaction as well as proper identification of the donor. Once Completed, please mail or email the Letter of Intention to the Diocese of Gary, Attn: Kathy Tomasik. Additionally, if the donation is intended for a parish, school or other organization, please send a copy to that organization.

Without a completed letter of intention, we will not know where to send the proceeds of the donation.

2. Transfer the stock (See page 4 for details).

You may transfer stock electronically (preferred), by mail, or in person.

 - iii. In a separate envelope send a completed, signed, dated and **medallion guaranteed irrevocable**Stock or Bond Power Form Page 3 of this document, together with a copy of the completed Stock Donation Letter of Intent.
- c. To hand deliver the securities:
 - i. DO NOT SIGN the stock certificate.
 - ii. Contact **Tom Devine of Peoples Bank, at 219-853 7086** to arrange a time to deliver the stock certificate(s), Irrevocable Stock or Bond Power and Stock Donation Letter of Intention.

Payment Processing and Acknowledgement of Donation:

The Diocese of Gary acts as a clearing house for donations of stock. When securities are donated, the Diocese of Gary bank (Peoples Bank) liquidates the securities and sends the proceeds to the Diocese along with a trade confirmation. The Diocese forwards the proceeds to the parish, school, or other institution as directed by the information provided in the Stock Donation Letter of Intention. Acknowledgement of the gift will be sent to the donor by the final gift recipient, not the Diocese of Gary.
